Respectable Use Policy (RUP):

Any other use or release of this data is prohibited.

By using any of these systems, users agree they will comply with this policy.

Misuse of these systems or the data contained in them may subject employees and students to Da Vinci disciplinary actions or prosecution consistent with the California Penal Code section 502. Da Vinci Schools reserve the right to revoke the access to any and all data or information system."

Compliance:

As pivotal members of the Da Vinci learning community, staff is expected to not only comply with Da Vinci's RUP, but to also help preserve our technology resources by reporting any misuse of Da Vinci's information systems to their supervisor, IT personnel, principal, or the Executive Director. It is only through the collaboration of all that we will successfully achieve our goal of providing the best possible educational technology environment for students and staff.

Important Information:

E-Mail Use Policy:

Because e-mail plays such an important role in conducting business, and because messages sent out through Da Vinci Schools' servers or with a Da Vinci Schools' e-mail address may be viewed as a reflection of Da Vinci Schools, e-mail etiquette and usage bear special consideration. Please pay close attention to Da Vinci Schools' E-mail Use Policy as it helps us ensure the best use of all our resources (human, physical, logical or digital).

Further Clarifications:

Although already implicit in Da Vinci Schools' RUP and E-Mail Use Policy, below are some examples of resource usage that fall outside Da Vinci Schools best practices. The use of Da Vinci Schools resources is therefore prohibited for:

- illegal activity, including copyright infringement, violation of contracts, or violation of any federal or state law;
- private financial or commercial gain or for private or commercial advertising;
- political lobbying, campaigning or advertising;
- invading the privacy of individuals or sharing personal data regarding students or Da Vinci Schools personnel, such as street address, phone number, home email address or photographs;
- transmitting information to students or parents/guardians of students on matters unrelated to the student's education:
- transmitting images or text that are obscene, pornographic, inflammatory, harassing, threatening, degrading, or harmful to others;
- transmitting material that plagiarizes another's work;
- transmitting information that harasses or disparages others based on their race, national origin, gender, sexual orientation, age, disability, religion, or political beliefs; and
- for transmitting false or unverified statements about others among others.

Violations may result in a loss of access as well as other disciplinary or legal actions.
