Discussion Items

Enrollment and Recruitment Update - Matt Wunder - see handouts

- 9th grade is slightly overenrolled, wait list of 126.
- 10th grade enrollment is low, 29 accepted students
- Don Brann concerned that August 17 start date may lead to some students leaving Da Vinci when other schools open in September; retention efforts are needed.



- Don Brann recommends not bringing in more students than available seats, bring them in as seats become available.
- Staff will decide whether 10th grade will be 32 or 64 students by next Tuesday or Wednesday, July 21-22.
 - Plan A 64 10th graders, decrease 9th graders by 32, total of 416.
 Plan B 32 10th graders, increase 9th graders by 32, total of 416.
- ADA target for budget was 400 students.
- 10th grade barbecue, Monday July 20th, 5-7pm Nicole Tempel
 - o Matt, Nicole, and Steve invited students by personal phone call.
 - Teachers will be present, will conduct tours of campus.
 - o Try to get the students committed to Da Vinci.
- 29 accepted students are all ready for 10th grade; quite a few students from Manhattan Beach and private schools.
- Student population comes from over 84 different schools in this neighborhood.
- Advertisement was in Westchester newspaper and Daily Breeze
- Da Vinci Overnighter- Erin Hughes see handout
 - o Part of retention strategy, to build rapport, community and identity within each school
 - Would happen after school starts, in rotations 10th grade, 9th grade science, 9th grade design on separate days
 - o Is the 2nd week too late? Mira Costa starts that same week; does it accomplish what we want? Dates were picked based on camp's availability.
 - Overnighter is not in the budget; recommendation that this users pay \$90 per student. Offer scholarships too, but everyone has to pay at least \$10.
 - o Gary will discuss bus costs with Erin Hughes, may be able to find a better
 - o Legally, if this event is on one of the school days, we have to offer an alternative to the child who cannot even afford the \$10. Not all students will be there at the same time, so school will be in session.
 - Staff hopes that Board members can come and visit the camp in Ramona while it's in session.
 - o Direction from Board try to offer this at \$90 per family
 - Designate a staff member as a contact for scholarships.

- 4467 partners purchased and remodeled an existing facility for Hawthorne Math and Science Academy, 600 students
- Business structure provides flexibility to district: can develop the property swiftly, facilitate the capital (used redevelopment agency funds in phase I)
- Real estate partnership owns the asset, charter school leases from partnership with specific opportunities to purchase the asset; can balance rent vs. purchase for different phases of the project.
- Comparison partnership built HMSA phase II in 5 months, plans for Dana rebuild sat in state office for 26 months.
- Rent flexibility additional payments towards purchase when funds are available allows reduction of rent.
- Phase III improvements multi-purpose and lunch area, classrooms, administrative space, library, converted old parking lot to athletic area, created a jogging track around campus
- Partnership makes acquisition, plan the development of the asset, construction or renovation according to the charter school's needs — District puts up some funds as option payments which count towards future acquisition cost; residual cost converts to extended lease, lease rates are tiered based on school's flow of funds.



- Loans are conservative, low leverage due to equity capital committed by partnership, stability of school district; biggest issue might be State of CA budget crisis.
- 4467 partnership includes mortgage banker and architect.
- HMS Costs: Phase I \$2.7M; Phase II \$4M; Phase III \$7M; now in a buyer's market
