Update on RISE Authorization 2018-19 and Beyond

Dr. Wunder spoke about meeting with Dr. Debra Duardo with Dr. Johnstone and Ms. Kari Croft. Discussion ensued regarding Wiseburn Unified School District acting as the monitoring agency, while the L.A. County Office of Education acts as authorizer of RISE High. Next steps are writing the charter petition for presentation to the County. Dr. Jones asked what happens to the existing five-year charter. Legal counsel will be consulted. Dr. Brann asked about XQ Institute's thoughts on this issue. Dr. Wunder spoke about XQ's invitation to Ms. Kari Croft to speak to the Emerson Collective in the Bay

Area. She was the only educator of all the XQ Schools to be invited. XQ Institute is being kept apprised of all the authorization issues.
