## Financial Update

Da Vinci Schools Chief Financial Officer, Marshall Mayotte, thanked the Managers for their welcome. He let them know he started on July 3, 2017.

Mr. Mayotte indicated that Mike Johnston of ExED was unable to attend the meeting. Mr. Johnston has indicated that ExED will prepare the PENSEC report (Pupil Estimates for New or Significantly Expanding Charters). Furthermore, Mr. Johnston wanted to communicate to the Managers that the budget changes and SB740 (charter funding for facilities) do not apply to RISE.

Dr. Brann asked how the work will be divided between Mr. Mayotte and ExED. Mr. Mayotte said that financial compilations and reporting will done by ExED. He compared the working relationship to driving a car: ExED is responsible for everything that has happened, like looking through a rearview mirror, while Mr. Mayotte is responsible for looking through the windshield and guiding the schools' future. Dr. Wunder added that Mr. Mayotte worked for ExEd in the past, so he is familiar with their systems and methods.

Mr. Mayotte informed the Managers that he would give the rest of his presentation in the Da Vinci Board meeting later in the evening.

## Item #2: School on Wheels (SOW) Partnership Proposal

Ms. Morgan inquired about the role of School on Wheels. Dr. Wunder replied that while Da Vinci Schools doesn't have a deep knowledge of the needs of homeless students, while School on Wheels does. They will assign one of their staff to be a RISE point person. Ms. Croft added that the School on Wheels point person will lead a workshop for RISE High teachers. A Place Called Home can provide wraparound services, but School on Wheels has the expertise specific to homeless students and ability to make referrals and help get students set up at the school.

Discussion regarding transportation ensued. Dr. Wunder pointed out that after a study was conducted, it was determined that transporting students is not feasible due to liability and insurance reasons. The team is currently looking at public and private transit options.

Dr. Brann inquired about XQ Institute's approval of the School on Wheels and A Place Called Home partnerships. Ms. Croft explained that XQ has met with A Place Called Home, and that School on Wheels has been supportive of RISE High for a long time. Natasha Bayus, School on Wheels' Director of Volunteer Engagement, was present when the RISE High team learned that they had won the XQ Super School grant.

The Managers requested the School on Wheels proposal be revised to remove mention of transportation prior to countersignature.
