Your participation assures us of continuing community interest in our schools. To assist you in speaking/participating in our meetings, the following guidelines are provided:

- 1. Agendas are available to all audience members at the meeting.
- 2. "Request to Speak" forms are available to all audience members who wish to speak on any agenda items or under the general category of "Public Comments." This is time set aside for members of the audience to raise issues that are not specifically on the agenda. However, due to public meeting laws, the Managers can only listen to your issue, not respond or take action. These presentations are limited to three (3) minutes and total time allotted to non-agenda items will not exceed twenty (20) minutes. Non-English speakers who use a translator shall have six (6) minutes in which to address the Managers.

The Managers may give direction to staff to respond to your concern or you may be offered the option of returning with a citizen-requested item.

- 3. The chair will recognize such individuals who wish to speak on a specific agenda item at the appropriate time. When addressing the Managers, speakers are requested to state their name and adhere to the time limits set forth.
- 4. Any public records relating to an agenda item for an open session of the Managers which are distributed to all, or a majority of all, of the Manager members shall be available for public inspection at 13530 Aviation Blvd., Hawthorne, CA 90250.
