You May Have Heard

What you may have heard....and here is what we understand specific to Da Vinci Schools:

- 1. Dr. Fauci, the CDC, and the State of California have said that it is safe to return to school under certain conditions with specific protocols in place. LA County remains in the highest tier of widespread transmission where grades 7-12 are unable to open. *Blueprint for a Safer Economy Coronavirus COVID-19 Response (ca.gov)*
- 2. Physical distance requirements mean all students cannot be on campus at one time. http://publichealth.lacounty.gov/media/coronavirus/reopening-la.htm#k12
- 3. Vaccination Timeline: Educators, students, and families of both also have differing timelines, with no approved vaccine for individuals under age 16. As of March 1st, educators can now access the vaccine. http://www.publichealth.lacounty.gov/media/Coronavirus/vaccine/index.htm
- 4. Transmission: Evolving research on asymptomatic transmission from the vaccinated to unvaccinated.

Health & Safety: COVID Compliance Team

DV COVID Compliance Team

- I monitors and implements guidance from state and local health officials
- manage re-opening protocols,
- **and if needed: implements an Exposure Management Plan**

DV COVID Compliance Team includes Leadership at the Central Office and All Sites

Defining Terms

<u>COHORT</u> refers to groups of students (with no more than 16 individuals in the group) who are meeting for targeted supports and intervention services while the school is closed to in-person instruction.

<u>STABLE GROUP</u> is a term used when a school is providing in-person instruction not under the Cohort Guidance (i.e., when it has opened for in-person instruction per the "open" definition in the Guidance). In this context, a stable group is a group with fixed membership of students and staff that stays together without mixing with any other groups for any activities, including instruction, meal times and recess.

<u>HYBRID</u> refers to an instructional model that includes remote instruction, with some on-campus activities & services

<u>REMOTE INSTRUCTION</u>, sometimes referred to as Distance Learning, is instruction provided to the student at home via online technology.

Health & Safety: Symptom Screening Checklist

Anyone entering building will be asked a set of screening questions and have their temperature taken. Anyone showing symptoms of COVID-19 or who may have been exposed to COVID-19 should not be at school.

Health & Safety: Face Coverings Staff and Students

As recommended by the CDC, CDPH and LACDPH, all staff and students required to wear face coverings at school.

- Face covering is defined as a cloth face covering OR mask of your choice
- Da Vinci will supply staff with 3 and students with 2 DV cloth face coverings
- Surgical masks available upon request
- Must be worn at all time when on DV campuses
- Need not wear a mask when alone in a private office or restroom stall.
- For those unable to tolerate a mask due to a developmental or medical condition, staff should contact HR and student should contact School Nurse

Health & Safety: Physical Distancing Protocols

Maintain at least six (6) feet distance from others

Tape or other markings are used to help students maintain physical distancing as they line up to enter the school. Multiple entrances and exits are used to avoid overcrowding at arrival and dismissals as long as all entrances and exits have adequate monitoring of arriving and exiting students and employees. **One way** traffic flows inside School employees are deployed in hallways to assure physical distancing as students move. **Staggered passing periods/schedules** Avoid the Three Cs **Classrooms and common spaces re-configured** Crowds Hybrid scheduling **Confined** spaces

Close contact

Health & Safety: Indoor Air Quality

Inspect HVAC systems to ensure they are in good, working order.

- Filtration Various solutions being implemented based on specific site needs.
- Ventilation- Promote ventilation where possible. Doors and windows are kept open during the school day if outdoor conditions make this appropriate.
- HVAC systems are set to maximize indoor/outdoor air exchange unless outdoor conditions (recent fire, very high outside temperature, high pollen count, etc.) make this inappropriate. This minimizes recirculation of air.

Selective use of HEPA Filter Air Purifiers

Health & Safety: Cleaning & Disinfecting

- Increased cleaning, sanitizing and disinfecting
 - $\circ~$ High touch frequencies
 - \circ Whole school
 - Micron Disinfection ULV fogging & electrostatic spraying
- Increased touchless hand sanitizer stations

Health & Safety: Positive Cases & Notifications

COVID-19 notification: If a known positive case is reported in DV community:

- Nurse/admin to request case to provide a list of other people with whom they had close contact 48 hours prior to symptoms
- Once close contacts are identified, the nurse will communicate with Public Health Department
- Nurse/HR will communicate to DV close contacts that they have potentially been exposed
- DV will not disclose the affected person's name
- School/Staff-wide notification to school community/other DV community/WUSD will be conducted in accordance with the law, including confidentiality of private medical information
- School site locations will be closed and cleaned per public health
- DV Schools will correspond with LADPH and CDC guidelines regarding school closure if required

Update 3/1:

Approx 2 million doses of COVID-19 vaccine administered across the county. 600, 497 people have received both doses.

Public Health Department have opened vaccinations to educators March 1, 2021.

In this next tier, educators together with childcare, food/agriculture, and law enforcement is approx 1.4 million Los Angeles residents.

With current rate of only 200,000 vaccine doses per week, it is anticipated this phase may last months.

10% of vaccine doses reserved for educators.




