# RETURN TO PLAY SAFETY PLAN

<p><b>A description of the team’s plan for meeting the routine testing requirements.</b></p>	<p>Student athletes and coaches are tested 2 days prior to every competition with at least one test weekly. PCR tests are used and made available through a site contract with Valencia Branch Laboratory. Opposing team is given date of negative test prior to competition.</p>
<p><b>A plan for entry screening for all workers, team support staff, and participants prior to entering the facility, practice, and competition.</b></p>	<p>All participants will be provided a link and a QR Code to Facilitron (<a href="http://www.facilitron.com">www.facilitron.com</a>) which provides an online, daily Health Check to be completed on the day of the athletic event. Instascan Temperature Scanning Systems and handheld no-contact thermometers will be used at designated entrances to screen for high temperatures.</p> <p>Students and coaches complete online symptom screening daily, are temperature screened upon entry, and are sent to isolation space for evaluation of any symptoms that develop during play.</p>
<p><b>A plan for reviewing test results and reporting positive results to LACDPH as required by this Protocol.</b></p>	<p>COLOR database is utilized (contracted with Valencia Branch Laboratory) to view results. School Nurse reports all positive cases to COVID compliance team and HR and a report is filed using online system with LACDPH. Coaches assist with contact tracing and identifying close contacts. Notifications of close contact and or possible exposure are sent to all affected asap. Students are given school nurse contact for resources as needed for isolation or quarantine.</p>
<p><b>A plan for ensuring that team participants are cohorted as much as possible</b></p>	<p>Each sport will develop cohorts by team levels. Examples: Varsity, Junior Varsity and Frosh/Soph. They will practice at different times, different facilities when available, and all equipment will be sanitized in between each practice.</p>

<p><b>A plan for ensuring that, when traveling to away games, the team must remain in the team cohort, with no mixing with the local teams or other members of the host community.</b></p>	<p>Any team traveling to an away game will remain together as a cohort including remaining cohorted while being transported to the away game, staying together at the venue of the event, and returning to their transportation after the game avoiding any instances of mixing with the host community.</p>
<p><b>A description of efforts that the team will make to comply with other aspects to this Protocol.</b></p>	<p>All coaches will work with the Athletic Director and School Nurse to ensure that any other aspects of this Protocol are familiar to them and adhered to in order to ensure the health and safety of all coaching staff, participating student athletes, and spectators.</p>
<p><b>A plan for communicating team safety modifications to participants, their families, and the public as needed.</b></p>	<p>This plan, and any updates made to it, will be provided on the COVID-19 Information Page of the Da Vinci Schools website as well as on the WDV Athletics webpage and blog which can be accessed by all parents, students, and community members as needed.</p>

<p><b>The entity sponsoring the sports team must designate a person responsible for responding to COVID-19 concerns for athletics overall, and for each team or sport, as applicable.</b></p>	<p>The designated person responsible for responding to COVID-19 concerns for athletics overall, and for each team or sport, as applicable, is Mr. Vicente Bravo, Chief Administrative Officer/Assistant Superintendent - Operations, Equity &amp; Compliance, and is supported by Dr. Emily Green, DV School Nurse, and Ms. Tori Grafeman, Interim Athletic Director.</p>
<p><b>The entity sponsoring the sports team must train and communicate with workers, worker representative (as applicable) and participants on the plan and make the plan available to workers and their representatives.</b></p>	<p>All coaches and coaching staff have been informed of the plan and can access it through the Da Vinci Schools website Athletics page, or they can request a copy of it from the DV Central Office. All staff were trained on the implementation of all protocols associated with this plan by the Chief Administrative Officer, School Nurse, and Interim Athletic Director.</p>
<p><b>The entity sponsoring the sports team must regularly evaluate the facility for compliance with the plan and document and correct deficiencies as identified.</b></p>	<p>All members of the staff will be constantly observing and reporting any issues, concerns, or challenges that may arise in order to consider any alternative solutions available for immediate implementation. Safety and health of our student athletes, coaches and staff remain the top priority in making sure that any deficiencies identified are addressed effectively.</p>

<p><b>The HVAC system has been inspected by an HVAC Specialist within 30 days of reopening for indoor sports and is in good, working order; to the maximum extent possible, ventilation has been increased. Effective ventilation is one of the most important ways to control small aerosol transmission.</b></p>	<p>The HVAC system of the Gym has been inspected in the last 30 days by EMCOR, our HVAC maintenance provider, and was determined to be in good working order. Indoor air quality improvements have been implemented. These include improvements for increased ventilation, continued use of MERV-16 filters, installation of GPS needlepoint bipolar ionization systems, portable, high-efficiency air purifying units (HEPA), and UV lights.</p>
